Almina Trading becomes MedLife

At the end of the purchase procedure of the company Almina Trading SA, MedLife also extends in Dâmbovița and Ilfov counties

Bucharest, 30 March 2017: MedLife, the leader of the private medical services in Romania, announces the completion of the purchase procedure of the majority of 80% of Almina Trading SA, a medical services company present on the Dâmbovița and Ilfov market, holding eight medical centres. As result of such transaction, the company Almina Trading will operate under MedLife umbrella.

Almina Trading has an activity of 20 years on the local market and it is the largest healthcare operator in Dâmbovița County. The company has eight medical centres – five in Târgoviște, two in Pucioasa and one in Buftea – and two laboratories (Târgoviște and Buftea), providing its patients with integrated outpatient, imaging and laboratory analysis services. The eight units are fitted with high-performing medical equipment and they are staffed with a medical team of over 125 specialists.

According to the representatives of the acquired company, Almina Trading had a turnover of approximately €1.3 million in the first 9 months of the year 2016.

We will be part of the group of the greatest private medical operator in Romania, which means new development and expansion opportunities for our team, which have already started. At this moment the MedLife group has reached the 15th purchase, Almina Trading and Anima being the last ones announced.
