## MedLife expands in Dâmboviţa and Ilfov and buys eight medical centres

*Bucharest, 20 January 2017:* MedLife, leader of the private healthcare market in Romania, announces the acquisition of the majority stake of 80% in Almina Trading SRL, a healthcare company present on the market in Dâmboviţa and Ilfov with eight medical centres.

Almina Trading SRL has an activity of 20 years on the local market and it is the largest healthcare operator in Dâmboviţa County. The company has eight medical centres – five in Târgoviṣte, two in Pucioasa and one in Buftea – and two laboratories (Târgoviṣte and Buftea), providing its patients with integrated outpatient, imaging and laboratory analysis services. The eight units are fitted with high-performing medical equipment and they are staffed with a medical team of over 125 specialists.

According to the representatives of the acquired company, Almina SRL had a turnover of approximately €1.3 million in the first 9 months of the year 2016.

"This acquisition marks the entry of MedLife on a new geographical area of Romania, contributing implicitly to the consolidation of its position nationwide. At the same time, this new project brings to our portfolio our 14<sup>th</sup> company acquisition. We also aim to continue our policy of growth through acquisitions", said Mihai Marcu, MedLife President and CEO.

"This partnership is an opportunity to develop our business, an important step in the evolution of our company by integrating processes and capturing the scale economy, and we are glad to become part of the largest operator on the private healthcare market in Romania", said Dr. Lavinia Ionescu, founder of Almina Trading SRL.

The acquisition of the majority stake in Almina SRL is the 14<sup>th</sup> such acquisition that the MedLife group has made so far, the last four taking place in less than year, with Panduri Medical Centre being the latest completed acquisition.
