## MedLife consolidates its top position in Braşov and invests in the expansion of the hospital, as well as in opening a new hyperclinic and a new laboratory

MedLife is the only operator in Brașov providing integrated healthcare services with hyperclinics, laboratories, maternity hospital, paediatrics centre, hospital and pharmacy

*2 February 2017, Braşov:* MedLife, leader of the private healthcare market in Romania, expands its presence in Braşov and announces the opening of a new hyperclinic and a new laboratory. Thus, by inaugurating these medical units and moving the outpatient care services in the new venue, the MedLife Braşov Hospital expands with 18 beds, with a day hospitalisation regime; currently the unit operates with a total number of 82 beds and 3 operating rooms.

MedLife consolidates thus its top position in Transylvania, as the only private healthcare services operator that provides patients with integrated outpatient services, imaging, laboratory tests, surgical interventions and hospitalisation, under the same roof.

"At the same time with this launch, part of the MedLife Braşov Hospital was freed to include a new hospital section with beds, the purpose of the construction being to render the services more efficient by adding hospital services to the existing fixed costs. We cover a wide range of surgical interventions, and due to the technology we have and our medical team, we can manage an increasing number of interventions of medium and high complexity. For this reason, our ongoing investments are a natural step towards our development in the hospital segment", said Mihai Marcu, MedLife President and CEO.

The new MedLife Brasov hyperclinic is located in the area of the Railway Station, on the spot formerly occupied by Lidl. It provides locals with investigations and treatments for 32 specialties, among which orthopaedics, general surgery, plastic surgery, pediatric surgery, gynecology, cardiology, diabetes, endocrinology, neurology and ENT. The new unit has 21 consulting rooms for examinations and clinical and paraclinical investigations, three treatment halls and two functional exploration rooms. The medical team consists of 95 physicians and support staff.

The new laboratory, the fourth unit in the MedLife Braşov portfolio, is structured on four departments (biochemistry, haematology, immunology and microbiology) and it is fitted with state-of-the-art equipment, of high accuracy and precision, providing a wide, complex range of investigations.

These two projects are the result of a €1.3 million investment and it covers an area of 1300 sqm.

"We entered the Braşov market 7 years ago, after completing a transaction to take over the Quick Diagnosis Polyclinic. We continued to invest, we increased the quality of our services and the complexity of the medical act, with Braşov becoming the second business centre for MedLife. We are pleased to offer locals and people from neighbouring areas a modern medical unit, where they can have customised prevention packages and integrated healthcare services of the highest standards. We will continue to

consolidate our position nationwide both with acquisitions and with greenfield projects", added Mihai Marcu.

MedLife Brașov Hyperclinic is located on 2 Turnului Street and it operates from Monday to Friday, between 8:00 a.m. and 9:00 p.m. and on Saturdays between 8:00 a.m. and 2:00 p.m. For information and appointments, patients can use the call centre number 0268 960.

MedLife entered the Brașov market in 2010, with the acquisition of the PDR Brașov group of companies. Currently, the MedLife portfolio includes a multidisciplinary hospital (MedLife Brașov Hospital), a maternity hospital (MedLife Eva Brașov Hospital), three hyperclinics (MedLife PDR Vulturului, MedLife PDR Turnului and MedLife Brașov), a Paediatrics Centre, six healthcare centres (Făgăraș, Sf. Gheorghe, Codlea, Bran, Poiana Brașov, Săcele), four medical laboratories (Brașov and Sf. Gheorghe) and an own pharmacy, part of the PharmaLife Med chain.
