

## **MedLife continues the expansion plan and announces the opening of the first hyperclinic in Oradea**

*In addition to the organic development of the new hyperclinic, the company announces the full acquisition of Transilvania Imaging Center, Oradea*

*26 September 2018, Oradea:* MedLife, the leader of the private medical services market in Romania, inaugurates the first hyperclinic in Oradea, which provides to citizens integrated services of **ambulatory, imaging and laboratory analyzes**, all under the same roof.

MedLife Hyperclinic is the result of an investment of 1.2 million euros, it covers an area of 1,100 square meters and is disposed on 3 levels. The unit includes a sampling point, five investigation rooms (gastroenterology, obstetrics-gynecology, pediatrics, urology, cardiology, etc.), a post-anesthetic salon and 12 cabinets for clinical and paraclinical consultations. The team consists of over 60 doctors, nurses and ancillary staff.

"The inauguration of the first MedLife Hyperclinic in Oradea supports our plans for national expansion. It is a growing city, and the opening of a large clinic here comes to meet patients and provide them with integrated medical services at the highest standards. As we announced from the beginning of the year to our investors and shareholders, we will continue our national expansion plan and market research, focusing on medium-sized cities," declared Mihai Marcu, President and CEO of MedLife.

Patients can access multidisciplinary medical services and treatments for 19 specialties, including internal medicine, pediatrics, orthopedics, gynecology, allergology, ENT, neurology, psychology, psychiatry, diabetes and nutrition, cardiology and dentistry. The imaging division includes high-performance ultrasounds that offer a great accuracy of diagnosis and complete endoscopic systems.

At present, MedLife is present in Oradea with an analysis laboratory, inaugurated in March this year, two sampling points and the hyperclinic, the latter one being the latest investment.

At the same time, MedLife announces today the **full takeover of Transilvania Imaging Center, Oradea**, a provider of diagnostic, imaging and radiology medical services, one of the most important players in the northwest part of the country on this segment. The center is equipped with high-performance medical equipment, while investigations are carried out by a team of specialists.

MedLife opened its first hyperclinic in 2004, and today it owns 20 such units in Bucharest, Arad, Timisoara, Galati, Iasi, Constanta, Craiova, Brasov, Cluj, Ploiesti and Braila.

As far as acquisitions are concerned, MedLife made its first acquisition in 2011 by buying the majority stake in PDR Brasov Group, and over the years, the company has successfully completed 20 acquisitions, being probably the healthcare provider with the greatest expertise
