Decision of the Competition Council no. 19/11.04.2018, on the investigation initiated on the basis of the Order of the President of the Competition Council no. 241/7.05.2015 and extended by the Order of the President of the Competition Council no. 1131/11.08.2017

Med Life S.A. received on 25.06.2018 the Decision of the Competition Council no. 19/11.04.2018 issued following the finalization of the investigation regarding the possible violation of the provisions of art. 5 of the Competition Law no. 21/1996, republished, by companies operating on the market for maternity hospitals and companies operating on the market for sampling, processing and storage of stem cells, and art. 6 of the Competition Law no. 21/1996, republished, by companies operating on the market for maternity hospitals.

During the investigation, the Competition Council found that the agreements concluded between the aforementioned companies represent violations of art. 5 par. (1) of the Competition Law, namely anti-competitive agreements which have had the effect of significantly restricting competition on the market for sampling, processing and storage of stem cells. Each of the companies under investigation has expressly, clearly, unequivocally and completely acknowledged the deed, as evidenced by the Competition Council's Investigation Report.

During the investigation, the Competition Council found that the investigated facts do not represent violations of art.6 par. (1) of the Competition Law.
